

Perkins Loan Assignment System Access Request

The Perkins Loan Assignment System (PLAS) enables users to electronically submit Federal Perkins Loan assignment information to the Department of Education. This Access Request Form allows administrators to request access for users, to modify information about existing users, and to terminate user access to PLAS.

To obtain access to PLAS, your institution must first designate an Institution Administrator. The designated Institution Administrator must complete this form to request, modify, and terminate access for themselves and all other users at your institution. Although your institution can only obtain access for *two* Institution Administrators, it can request access for as many Institution Users as needed to submit, edit, and delete assignments for the Federal Perkins Loan Program (including NDSL and Defense Loans).

In order to obtain administrative rights, the designated Institution Administrator must first request access to PLAS by completing this PLAS Access Request Form. See how to [Designate an Institution Administrator](#) in the table on page 3.

The Institution Administrator will use this form to request access for all other users of PLAS, as well as to modify or terminate user access. For a complete list of [Administrative Responsibilities](#), see page 8.

Two Factor Authentication

Similar to the security process used to access Federal Student Aid systems, such as the eCampus-Based (eCB) System, authorized users of the PLAS are required to enter two forms of “authentication” to access the system.

This security process is an established technology referred to as Two Factor Authentication (TFA). TFA will require each authorized user to log in to PLAS with his or her Login ID and Password as well as a Security Code generated by a registered TFA token.

If a user already has a TFA token because he or she also has access to one of Federal Student Aid’s systems, the user only needs to complete the PLAS User Access Form steps outlined below.

If a user does not have a TFA token, the user should contact the institution’s Primary Destination Point Administrator (DPA) for Federal Student Aid systems to obtain one. Once the token is received, it will need to be registered. In addition, the user will need to complete the PLAS User Access Form steps outlined below.



Note: The institution's Primary DPA for Federal Student Aid systems is not required to be the same person as the institution's designated Institution Administrator for PLAS.

Submitting the PLAS Access Request Form

1. Complete all required fields on the form.

3. Retain a copy of the completed and signed forms for your records.

After ECSI Federal Perkins Loan Servicer receives and processes the PLAS Access Request Form, the user will receive an email from ECSI PLAS Support with his or her PLAS Login ID and instructions for obtaining a temporary password.

Important

User status will be changed to *Inactive* if:

- User fails to log into PLAS to change their temporary password within the first 30 days.
- User fails to access PLAS for a period of 180 days after establishing a password.

Responsibilities of a PLAS Institution Administrator

1. Complete a User Access Request Form to add a new user, to modify information about an existing user, or to terminate a user’s access to PLAS.

2. Submit User Access Request Forms to ECSI Federal Perkins Loan Servicer.

3. Notify ECSI Perkins Loan Servicer when a user’s access is modified or terminated.
 - Modified account requests include changes made to a user’s contact information or Two-Factor Authentication (TFA) device.
 - If you are terminating access for a user, the form must be completed and returned to ECSI within 24 hours of effective date.
4. Administer TFA devices in accordance with the U.S. Department of Education’s requirements.
5. Retain copies of all institution Perkins Loan Assignment System Access Request forms.

I acknowledge receipt of the responsibilities explained above. I accept responsibility as the PLAS Institution Administrator and agree to manage user access for my institution accordingly. I will comply with all access administration responsibilities. I understand that failure to abide by the above rules and responsibilities may lead to permanent loss of access to the PLAS.
